 - a) Examine the contribution, of **either** one early Church Father **or** Apologist that you have studied, to the ways of interpreting the Old Testament; [30]
 - b) Discuss the strengths and weaknesses of the approaches that you have examined in (a); [30]
 - c) Demonstrate how you would apply any one of the approaches you have examined in (a) in your reading and interpretation of the Old Testament. [40]
- 2. Orthodoxy and heresy were hot issues during the Patristic Era.
 - a) Analyze the contribution of the different interpretations of the Old Testament to the issues of orthodoxy and heresy during the patristic era. [30]
 - b) In the light of your answer in (a), discuss the proposals given by Irenaeus and Tertullian for guiding, discerning and safeguarding the correct meaning of passages of Scripture; [30]
 - c) Learning from Irenaeus and Tertullian's approaches and interpretations of the Old Testament, propose an approach to the Old Testament that may make Scripture relevant to your context.

 - a) Traditionally it has been proposed that there were two distinct exegetical schools in the 2nd and 3rd century early Church.
 - i. Give a critical summary of this proposal;
 - ii. Discuss the legitimacy and appropriateness of this proposal; [30]
 - iii. Examine the factors that contributed to the approach and methods in the reading and interpretation of the Old Testament during this period. [40]
