Unnoticed, his three-year-old son Teddy crawled into the pool and died instantly as a result of drowning. Kudzai is charged with murder and he approaches you for advice on the appropriateness of the charge.

### **Question 5**

Thatho is a fresh High school graduate who has been dreaming of living abroad. To ensure that his dream comes true, he did a short course in Nurse Aid. He was lucky

enough to get a position in the UK as an Aid worker in a very busy hospital. Thatho was assigned to look after Mr Smith a critical patient who was involved in a fatal car accident. After three months of caring and aiding Mr Smith, Mr Smith started showing great signs of recovery. Thatho then became reluctant in caring for Mr Smith. As a result of Thatho's conduct, Mr Smith developed serious bedsores which became infected leading to his death as a result of infected wounds. Can Thatho be found liable for the death of Mr Smith? Discuss. (15)

#### **Question 6**

D stabbed C on the chest while they were fighting. An ambulance was called to rush C to the hospital. As the ambulance was approaching Christmas Pass, it collided with a huge timber truck. C was squashed by timber and died on spot. Can D be found liable for the death of C? Briefly discuss. (5)
