Part A (Compulsory to all candidates)

Sandy is a resident of Mutare. On the 1st of September 2022 Sandy was arrested in Masvingo for theft that occurred in the same province. The allegations against him were that Sandy stole the sum of \$15 000 from the National Parks office. Sandy is denying the allegations, his defence being that he was not in Masvingo at the time of the alleged theft. Rather he was at home in Mutare where he was celebrating the 5th birthday of his son. He claims he has a couple of witnesses that can vouch for his story including several five year olds who saw him at the party. Despite his claim, the police are proceeding with Sandy's prosecution and have served Sandy with summons to appear in court for theft.

- a) Which court has jurisdiction to try Sandy of the crime of theft in the above case? Justify your answer. [12marks]
- b) Tatenda a boy aged 25 years of age and Joana a girl aged 24 years of age married customarily in terms of the new Marriage Act. The marriage was solemnized by a chief in terms of the law. Five years after their marriage the parties have irreconcilable differences that centre on allegations of infidelity, abuse and cruelty. These allegations are made by both parties against each other. Explain the court that has jurisdiction to dissolve Tatenda and Joana's marriage. [8marks]
- c) "Lawyers are required by ethical rules of the profession to keep confidentiality". Explain what this mean? [5marks]
